MESSAGE FROM LEADERSHIP

Isolation protocols have worked in Eeyou Istchee for months now at keeping Eeyou Istchee as one of the jurisdictions with the fewest cases of COVID-19 in Quebec.

There are currently two types of Isolation Protocols both having legal and enforceable status:

- **MSIL**: Mandatory Self-Isolation Laws under local jurisdictions (Currently 5 days for those with 3 doses of vaccine + test on Day 5 and 10 days for those with less than three doses + test on Day 5 to 7)
- **Medical**: Medical Self-Isolation under the Authority of the Public Health Authority for our Region (Currently 10 days regardless of vaccination)

The people of Eeyou Istchee need to be congratulated and thanked for the very high-level of compliance that we have with both isolation protocols. For the few that do not comply there is a risk of serious consequences for breaching protocols:

- **MSIL**: A person arriving from an Area of Risk will have their name placed on a public registry. Breach of the protocol begins with the incident being brought to the attention of the local Public Safety Officer who works with the EEPF administering notices of breach and a fine.
- Medical: Names of people under this protocol cannot have their name on a
 public registry because it is private information related to their medical status.
 Breaches of this protocol begins with the incident being brought to the
 attention of the Public Safety Officer who works with a Public Health
 representative and coordinates the intervention of the EEPF for the imposing
 of a fine.

EDUCATION

Schools and Adult General education will be starting online on January 12 to January 26, 2022. Please continue to check for any updates from your local school. All vocational training programs in the communities will start in-person, health and safety measures permitting, on Wednesday, January 26, 2022. The SRVTC facility is closed until January 26th, 2022

Post-Secondary Student Services offices are closed. PSSS employees are teleworking and can be reached by email and telephone. They can be contacted through the PSSS Montreal Office number **1-800-463-7402** and PSSS Gatineau office number **1-800-567-9667**. PSSS continues to monitor the situation of its students. All CSB Offices are closed. Teleworking for most employees is mandatory, except for essential workers required on site.

Effective December 30th, 2021 at 11:59 PM the Cree Communities of Eeyou Istchee are considered Areas of Risk (See Map).

^{*} When isolating, whether indoor or outdoor, it is important to remain at 2 meters and masked from those that are not in isolation. Please refrain from going to any public areas while in isolation or part of a contact tracing exercise.

*Medical Isolation after a Positive Test

- the Health Board will inform you of how long you will need to isolate (minimally 10 days from the day of testing positive)
- if you are part of a contact tracing exercise you will have to isolate for 10 days, even if you test negative
- if you cannot safely isolate in the house with people not in isolation it is imperative that you contact the local clinic.
