# CNRI PROJECT OVERVIEW

The Cree Nation Research Institute (CNRI) project is a transformative initiative aimed at leveraging research to support the self-governance, cultural preservation, and economic development of the Cree Nation. Historically, research in Eeyou Istchee has often excluded Cree involvement, leading to a disconnect between research outcomes and community needs. The CNRI seeks to bridge this gap by establishing a research governance framework that aligns with the aspirations of the Cree communities.

## **MILESTONES OF THE CNRI PROJECT**

#### 2022: ESTABLISHING THE WORKING GROUP

In 2022, Deputy Grand Chief Norman A. Wapachee initiated the CNRI project by forming a Working Group. This group, supported by the Cree Nation Government, was tasked with planning the creation of the Institute. Early efforts focused on identifying the primary goals and gathering insights from various stakeholders to ensure the project addressed the core needs and aspirations of the Cree communities.

#### 2023-2024: COMMUNITY CONSULTATIONS

Between November 2023 and March 2024, extensive consultations were conducted with Cree First Nations and regional organizations across Eeyou Istchee. These consultations were crucial in shaping the trajectory of the CNRI, providing a platform for collective decision-making, and understanding how the Institute could best support the research endeavors of the Cree Nation. Feedback from these sessions led to the formulation of three specific mandates for the CNRI.

#### MARCH 2024: FORUM ON RESEARCH IN EEYOU ISTCHEE

A significant milestone was the Forum on Research held at the Aanischaaukamikw Cree Cultural Institute in Ouje-Bougoumou on March 19-20, 2024. This event brought together representatives from all Cree communities and organizations to discuss and refine the CNRI's mandates. The positive feedback and collaborative discussions at the forum were instrumental in advancing the project's development and setting a clear path forward. The three mandates, stemming from the consultation process, were well-received during the forum.

# THE THREE CNRI MANDATES PROPOSALS

The main outcomes of the preconsultations were three mandates proposals for the new entity which were presented to the Cree Nation at the Forum on Research in Eeyou Istchee

These mandates aim to ensure that research conducted in Eeyou Istchee is aligned with the Cree Nation's goals and provides tangible benefits to the communities.

### FORUM ON RESEARCH IN EEYOU ISTCHEE

# AANISCHAAUKAMIKW CREE CULTURAL INSTITUTE (OUJE-BOUGOUMOU) March 27-28, 2024

The recent two-day Forum on Research in Eeyou Istchee brought together Cree stakeholders to shape the vision for the Cree Nation Research Institute (CNRI). Representatives from all Cree First Nations and almost all regional organizations participated, using the event as a platform to share insights on research management and governance.

The forum emphasized the importance of community involvement in research review processes, highlighting the need for collaboration, transparent communication, and community consent. Participants suggested that the CNRI could serve as a clearing house for researchers working in Eeyou Istchee.

Discussions focused on current research priorities, the role of a Cree research entity in supporting communities, and the importance of aligning research with Cree values. Attendees stressed the need for Elder involvement, face-to-face relationships, and a Cree Code of Ethics. Proposals for data governance included a regional research data portal and coordinated data management. Support was expressed for CNRI as a hub for Cree research and partnerships, with recommendations for fostering self-governance, preventing research duplication, and developing training programs.

### CALL TO ACTION: THE CNRI ADVISORY COMMITTEE

Forum attendees endorsed a proposed structure featuring a larger Advisory Committee to guide a smaller, efficient Steering Committee, emphasizing the importance of transparency and regular communication with the Cree Nation. Following the forum, a letter was sent to all Cree First Nations and Cree regional organizations inviting them to appoint permanent representatives to the Advisory Committee, with the first meeting scheduled for late November.
