Eeyou EcoFund – Application Guide (2025–2026)

(Currently open for Biodiversity Conservation Projects Only)

1. Introduction

Rooted in Cree values and supported through Nation-to-Nation agreements with the *Gouvernement du Québec*, the **Eeyou EcoFund** is a Cree Nation Government program that supports Cree-led biodiversity conservation projects in Eeyou Istchee and Québec's **2030 Nature Plan** and in line with international biodiversity goals. This vital initiative is funded through *Ministère de l'Environnement*, *de la Lutte contre les changements climatiques*, *de la Faune et des Parcs* (MELCCFP) financing for *Indigenous Leadership in Biodiversity Conservation*. All projects must be Cree-led and benefit Cree people, lands, waters, and way of life.

2. Eligibility

Eligible Applicants:

- Cree Nation Government entities
- Cree communities, organizations, or businesses*
- Recognized Cree partners with Cree leadership (Cree majority in partnerships)

Eligibility Criteria:

- Projects must take place in **Eeyou Istchee James Bay region***.
- Projects must be Cree-led (majority Cree if partners are involved).
- Projects must align with at least one 2030 Nature Plan target (see Annex 4).
- Project must align with eligible expenses (see below)

Ineligible Applicants:

- Federal or provincial ministries
- External organizations without Cree majority leadership
- Entities in default of prior Quebec aid obligations

*Note - This may limit projects led by MoCreebec or undertaken in Whapmagoostui. For these specific instances, please consult us prior to submitting an application.



^{*}Businesses must either have a NEQ (Numéro d'entreprise du Québec) and/or be listed in the Cree Business Registry



3. Eligible & Ineligible Expenses

Eligible Expenses:

- Salaries, benefits, and professional fees (with preference for Cree capacity)
- Honoraria for Elders, Knowledge Holders, land users (250\$/day)
- Workshops, ceremonies, meetings, and community engagement
- Travel and accommodation within Eeyou Istchee
- Equipment, tools, safety gear, communication, translation
- Administrative costs up to 10% of project total.
- Professional fees should not surpass salaries.

*Note that in the Budget Template you will find a Guidance tab which provides more examples of the types of expenses possible and under which expense category they fit.

Ineligible Expenses:

- General operating costs unrelated to the project
- Costs incurred before project approval
- Activities outside Québec
- Land purchases or real estate
- Greenhouse gas offsets
- Legal proceedings

4. Funding Amounts & Payments

- Local Projects (community-level): up to \$200,000 per year
- Regional Projects (multi-community or territory-wide): up to \$500,000 per year

Standard payment schedule:

- 50% on signing of Contribution Agreement
- 25% on approved progress report (or mid-journey if grant is less than \$50k)
- 25% on approved final report

Applicants must disclose total project costs, including contributions from their own organization and other partners (cash or in-kind). Using provincial funding for the same activities is not permitted.



5. Examples of Eligible Biodiversity Projects

Species & Habitat Protection

- Protection and recovery of threatened or culturally significant species
- Habitat restoration projects (wetlands, forests, riparian zones)
- Control or prevention of invasive species

Knowledge & Capacity Building

- Traditional knowledge documentation with Elders and youth
- Community training and awareness campaigns on biodiversity
- Development of tools for monitoring and data collection
- Biodiversity research and inventories in partnership with communities

Protected Areas & Conservation Planning

- Inventories and mapping of biodiversity hotspots
- Development of protected area proposals under Cree leadership
- Planning for biodiversity corridors and ecological connectivity
- Community-led monitoring of protected areas

Community Engagement

- Youth programs for conservation and biodiversity awareness
- Intergenerational workshops with Elders, youth, and land users
- Cultural activities linked to biodiversity education
- Awareness campaigns on 2030 Nature Plan targets

6. Examples of Ineligible Projects

Projects that will **not** be funded include:

- General operational support for an organization (e.g., core salaries not tied to a project)
- Activities located outside of Québec
- Legal or political lobbying activities
- Purchase of land, buildings, or major infrastructure
- Greenhouse gas offset credits
- Projects unrelated to biodiversity/nature priorities
- Duplicated funding requests already supported by Québec for the same activities *

*Although it is not acceptable to "double dip" from similar funds, it is permissible to combine funds from other sources/purposes in order to achieve project objectives.



7. Application Process

- 1. Download the Application Form (Word) and Budget Template (Excel) at https://www.cngov.ca/ecofund/apply/
- 2. Complete the form and budget snapshot
- 3. Attach supporting documents (optional but encouraged)
- 4. Submit by email to ecofund@cngov.ca

8. Clarifying Application Requirements

- Contact Information is mandatory.
- Applicant Name: Enter name of person leading the work and authorized to apply on behalf of the organization. (Individuals must apply through a Cree-led entity).
- Project Location: Applicants must indicate where the project will take place by selecting one or more of the following:
 - Community (if community-wide)
 - Trapline (if trapline-based)
 - Coordinates or Address (if site-specific)

9. What Happens After You Apply

- 1. **Secretariat Review** Applications are screened for eligibility and completeness.
- 2. Selection Committee Review Applications are assessed for alignment, feasibility, budget clarity, capacity, knowledge integration, risk management, partnerships, and innovation. (See Annex 2 for the full list of evaluation criteria.)
- 3. Steering Committee Review Recommendations are validated and funding amounts confirmed.
- 4. Contribution Agreement Approved proponents will sign a funding agreement with the Cree Nation Government.
- 5. **Project Launch** Funds are disbursed, and the project begins.

10. Reporting

- All projects must submit a Final Report within 45 days of completion.
- Projects over \$50k must also submit a Progress Report.
- Templates and instructions are provided to successful applicants with their agreement.

□ Identified Local or Regional project type
□ Provided project location (community, trapline, category of land, or coordinates)
□ Specified funding request, contributions, and total project cost
\square Indicated primary and secondary 2030 Nature Plan target(s) (see Annex 4 below)
□ Attached Excel budget
\square Attached supporting documents (optional: Council resolution, letters of support, proof
of registry, maps, etc.)
\square Signed the Declaration section of the Application Form

Annex 3 – Evaluation Criteria

Projects are assessed by the Selection Committee on the following factors:

- a) Alignment with 2030 Nature Plan goals (see Annex 4)
- b) Community relevance (need, involvement of youth/Elders)
- c) Technical feasibility (activities are realistic and achievable)
- d) Budget clarity (reasonable, justified)
- e) Environmental and social impact (long-term benefits, cultural integration)
- f) Capacity and risk management (ability to deliver, contingency measures)
- g) Partnerships and collaboration (local/regional synergies)
- h) Innovation (creative or pilot project value)
